CIRCULAR

Whereas, this office vide letter dated 07.08.2023, circulated an advisory no 10 of Commission Of Air Quality Management (CAQM) dated 19.07.2023 to the Principal Secretary, Transport Department neighbouring states, Uttar Pradesh, Haryana and Rajasthan for strict compliance, read as:

1. W.e.f. 01.11.2023, all buses originated from NCR Districts in the respective States and plying to Delhi will be either Electric Vehicles or CNG or BS-VI Diesel.
2. Plan and target to achieve that all buses originated or terminating in NCR to operate only on CNG/Electric Vehicle Mode by 30.06.2026.
3. Plan and target substantial number of buses originated or terminating in NCR will operate only on Electric Vehicle Mode by 30.06.2028.

Now, the CAQM vide circular dated 19.10.2023 has circulated direction vide Direction No.78, as per powers conferred under section 12(2)(ix) read with section 12(2)(v) of Commission For Air Quality Management in National Capital Region and Adjoining Areas Act 2021, for strict compliance by all concern. The directives are reiterated here in below:-

Haryana

(i) All State Govt. bus services between any city/town in the State of Haryana and Delhi shall be operated only through EV/CNG/ BS-VI Diesel buses w.e.f. 01.11.2023. This shall also be applicable for bus services being operated by State PSUs and private entities etc.

Rajasthan

(i) All bus services between any NCR city/town in the State of Rajasthan and Delhi as also to any other city/town in NCR, shall be operated only through EV/CNG/BS-VI Diesel buses w.e.f 01.11.2023. This shall also be applicable for bus services being operated by State PSUs and private entities etc.

(ii) All bus services from non-NCR areas of Rajasthan to Delhi shall also be ensured through EV/CNG/BS-VI Diesel buses w.e.f. 01.01.2024. This shall also be applicable for bus services being operated by State PSUs and private entities etc.

Uttar Pradesh

(i) All bus services between any NCR city/town in the State of Uttar Pradesh and Delhi shall be operated only through EV/CNG/BS-VI Diesel buses w.e.f. 01.11.2023. This shall also be applicable for bus services being operated by State PSUs and private entities etc.


(ii) All 1433 State Govt. buses operating between non-NCR areas of the State to Delhi and NCR areas of other States shall also be ensured through BS-VI diesel compliant buses w.e.f. 01.07.2024. This shall also be applicable for bus services being operated by State PSUs and private entities etc.

Further, w.e.f 01.07.2024, all bus services from the any city town in states Haryana, Rajasthan Uttar Pradesh to Delhi/other areas of NCR shall be only with EV/CNG/BSVI Diesel buses.

Therefore, attention is invited of concerned state transport undertakings and Private entities, that the directives of CAQM must be complied. Any deviation, whatsoever, will be treated as violation of various provisions stipulates in Motor Vehicle Act 1988, and the rules framed thereunder which invite even action under Section 207 of Motor Vehicle Act 1988. All concerned are requested to acknowledge the above directions.
