ORDER

Subject: - Directions under section 12 of Commission for Air Quality Management in NCR and Adjoining Areas Act, 2021 - Migration of public transport services especially buses in NCR to cleaner modes.

Commission for Air Quality Management in National Capital Region and Adjoining Areas (CAQM) vide its Direction No. 78 issued vide F.No. A-110018/01/2021-CAQM dated 19.10.2023 on the above cited subject, has directed for ensuring for strict implementation of the targeted timelines, as committed by the respective States, in respect of the inter-city / inter-state bus services serving Delhi and other cities / towns in NCR, which is as under:-

Haryana

- i) All State Govt. bus services **between any city / town** in the State of Haryana and Delhi shall be operated only through **EV/CNG/BS-VI Diesel buses w.e.f 01.11.2023**. This shall also be applicable for bus services being operated by State PSUs and private entities etc.

Rajasthan

- i) All bus services between **any NCR city / town** in the State of Rajasthan and Delhi as also to any other city / town in NCR, shall be operated only through **EV/CNG/BS-VI Diesel buses w.e.f 01.11.2023**. This shall also be applicable for bus services being operated by State PSUs and private entities etc.
- ii) All bus services from **non-NCR areas of Rajasthan** to Delhi shall also be ensured through **EV/CNG/BS-VI Diesel buses w.e.f 01.01.2024**. This shall also be applicable for bus services being operated by State PSUs and private entities etc.

Uttar Pradesh

- i) All bus services between any **NCR city / town** in the State of Uttar Pradesh and Delhi shall be operated only through **EV/CNG/BS-VI Diesel buses w.e.f 01.11.2023**. This shall also be applicable for bus services being operated by State PSUs and private entities etc.

- ii) A total of 874 State Govt. buses are presently plying within the 8 NCR districts of UP, of which at least 250 buses shall be **BS-VI Diesel** compliant **w.e.f. 01.01.2024** and the balance services shall also be through **BS-VI Diesel** compliant buses **w.e.f. 01.04.2024**. This shall also be applicable for bus services being operated by State PSUs and private entities etc.
- iii) All 1433 State Govt. buses operating between **non-NCR areas** of the State to Delhi and **NCR areas** of other States shall also be ensured through **BSVI diesel** compliant buses **w.e.f. 01.07.2024**. This shall also be applicable for bus services being operated by State PSUs and private entities etc.

In effect, w.e.f. 01.07.2024, all bus services from any city / town in the States of Haryana, Rajasthan and Uttar Pradesh to Delhi / other areas in NCR shall be only with EV/ CNG/ IBS-VI Diesel buses.

Transport Department, GNCT of Delhi vide its circular No. F. TPT/AS/STA/Misc.-4/2021/075681535/98288 dated 26.10.2023, addressed to Transport Authorities of the States of Haryana, Uttar Pradesh and Rajasthan, has stated that any deviation to the above directions, whatsoever, will be treated as violation of various provisions stipulated in Motor Vehicles Act, 1988, and the rules framed thereunder which invite even action under Section 207 of Motor Vehicles Act, 1988. A copy of the said circular is also enclosed herewith which is self-explanatory.

All DCsP/Traffic Ranges and ACsP/Traffic Districts are directed to brief and sensitize the staff working under their operational control to comply with the above directions. The directions of the CAQM should also be widely disseminate at ISBTs and amongst the transport association/unions of their respective areas. The Road Safety Cell/Traffic and PIU/Traffic should also disseminate this information in road safety awareness programmes and at social media platforms for guidance of the general public/stakeholders.
